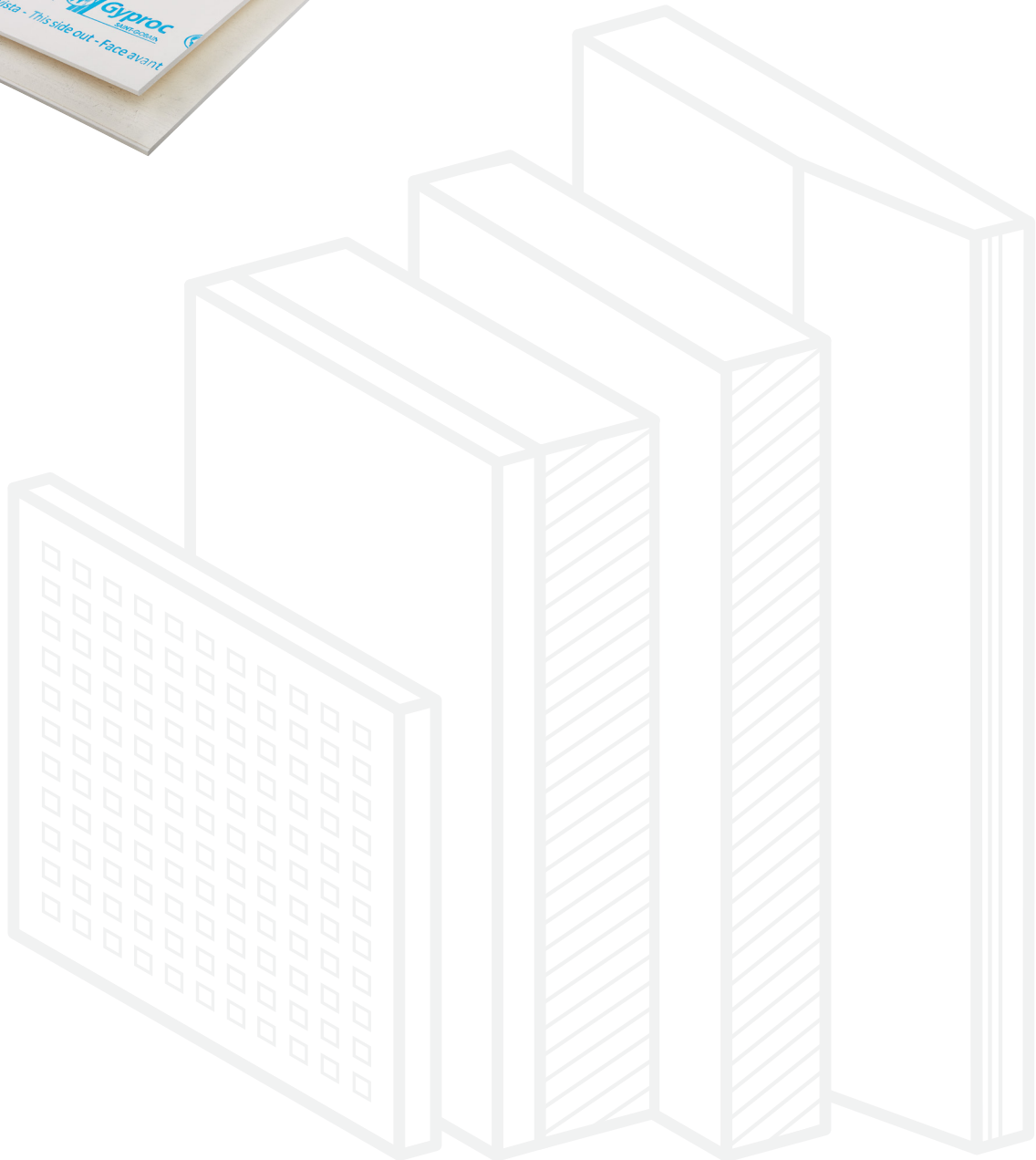

**Composition comments** Glasroc X is a gypsum board with mat reinforcement which has inherent mould resistant properties. The glass fibre mat protects the board with its hydrophobic coating, and has additional UV resistant properties. Natural board constituents may include minor amounts of quartz.

#### 4.1. Description of first aid measures
